Dear Mr. Clapp,

This letter is regarding the enclosed violation and order to remedy issued to the above referenced property resulting from a field inspection at the property on April  $14^{\rm th}$ , 2025.

While performing the inspection it was observed that the structure is in violation of the Property Maintenance Code of NYS. During our inspection, you stated that you intend to secure and repair the structure upon approval from the Town of Cape Vincent for your intended use of the property. Although a delay in repairing the structure is understandable under the circumstances, property violations are present, and it is the responsibility of this office to protect the public from unsafe building conditions.

While you are waiting for the required approvals to proceed with your project, you will be required to

increase the distance of the fence already encompassing your building to accommodate for possible collapse of the structure. Please provide supporting documentation from a NYS design professional for a safe distance to protect the public from possible collapse. Enforcement will be suspended upon an inspection confirming completion of the increased fence setbacks. This suspension is specific only to violation #25-0020. This suspension will only remain in place until a decision has been made by the Town of Cape Vincent, at which time we will need either an application for a building permit or a demolition permit to completely remediate the unsafe condition of the structure.

Please be advised that our office reserves the right and discretion to cancel this suspension at any time and to move forward with enforcement if we deem it to be in the public interest to do so.
